AN ORDINANCE AMENDING AN ORDINANCE OF THE CITY OF WILLIAMSPORT BEING KNOWN AS COUNCIL BILL NO. 2868, APPROVED JANUARY 21, 1961, AS AMENDED, ESTABLISHING STOP SIGNS, PARKING SIGNS AND OTHER CHANGES TO THE TRAFFIC CODE AND AMENDING TRAFFIC CONTROL MAPS.

IT IS HEREBY ORDAINED AND ENACTED AS FOLLOWS:

SECTION I: Article 3, Section 2, of the above cited ordinance of the City of Williamsport is hereby amended in order that the traffic control maps shall show the following changes and additions:

<u>DATE OF CHANGE</u>	<u>TYPE</u>	<u>LOCATION</u>
10/9/13	Remove No Parking Anytime	Oliver Street, west side, between Memorial Avenue and Taylor Place
12/13/13	Install No Parking Anytime	West Third Street, south side, between Grier and Susquehanna Streets
12/13/13	Install No Parking Anytime	West Third Street, north side, between Susquehanna and Park Streets
3/20/14	Install No Parking Anytime	High Street, south side, between Beeber and Oliver Streets
4/9/14	Install No Parking Here to Corner	Southwest corner of Arch Street at Dewey Avenue

SECTION II: Proper city officials are hereby authorized and directed to change the traffic control maps of the City of Williamsport to reflect the amendments set forth in Section I thereof.
