AN ORDINANCE 6275

VACATING PORTIONS OF NEECE STREET AND POTTER STREET

BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLIAMSPORT AND IT IS HEREBY ENACTED UNDER THE AUTHORITY OF THE SAME THAT:

SECTION 1: A portion of Neece Street in the Fifth Ward of the City of Williamsport, County of Lycoming, Pennsylvania, as set forth in the plan prepared by Richard M. Trowbridge, PLS, dated February 3, 2015, attached hereto is vacated:

All that certain piece of Neece Street situate in the Fifth Ward, City of Williamsport, Lycoming County, Pennsylvania, bounded and described as follows:

Beginning at the northeast corner of Neece Street and West Fourth Street; thence along the Tax Parcels 65-01-114 and 65-01-101, South 4° 04' 49" East, 267.57 feet; thence continuing along Tax Parcel 65-01-114 South 25° 16' 57" East, 18.84 feet; thence along the northern line of Potter Street, South 85° 55' 11" 26.81 feet; thence along Tax Parcel 65-01-114, North 4° 04' 49" West, 285.48 feet; thence along the southern line of West Fourth Street, North 86° 54' 11" East, 20.00 feet to the point of beginning.

Containing 5,875 Square Feet

SECTION 2: A portion of Potter Street in the Fifth Ward of the City of Williamsport, County of Lycoming, Pennsylvania, as set forth in the plan prepared by Richard M. Trowbridge, PLS, dated February 3, 2015, attached hereto is vacated:

All that certain piece of Potter Street situate in the Fifth Ward, City of Williamsport, Lycoming County, Pennsylvania, bounded and described as follows:

Beginning at a point at the northern line of Potter Street, being 153.13' from the western line of Hepburn Street; thence through Potter Street South 4° 00' 48" East, 20 feet; thence along Tax Parcels 65-01-135 and 65-01-120 South 85° 55' 11" West, 90.34 feet; thence continuing along Tax Parcel 65-01-120, South 71° 27' 13" West, 26.20 feet, thence along Tax Parcel 65-01-116, North 4° 04' 49" West, 26.54 feet; thence along the southern terminus of vacated Neece Street and Tax Parcel 65-01-101 North 85° 55' 11" East, 115.73 feet to the point of beginning.

Containing 2,397 Square Feet

SECTION 3: The proper city officials are hereby authorized and directed to reflect the above-mentioned change on the official map of the City of Williamsport.
