### AN ORDINANCE DESIGNATING J. MARLYNE WHALEY WAY

BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLIAMSPORT AS FOLLOWS:

SECTION I: The public street now designated as Walnut Street, between Little League Boulevard and High Street, also be hereinafter designated as J. Marlyne Whaley Way.

SECTION II: The proper city officials are hereby authorized and directed to make such designation upon the official map of the City of Williamsport.

**SECTION III**: This ordinance shall take effect 20 days after final enactment.
