AN ORDINANCE

AN ORDINANCE AMENDING ARTICLE 199 OF THE CODIFIED ORDINANCES
(EAST THIRD STREET GATEWAY REVITALIZATION ORDINANCE)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLIAMSPORT as follows:

SECTION 1. ARTICLE 199.02 – MEMBERSHIP; TERM IS HEREBY AMENDED TO READ AS FOLLOWS:

- (a) The East Third Street Revitalization Gateway Advisory Commission shall consist of twelve (12) members who shall be appointed in the following manner: Four (4) members shall be residents of the City and appointed by the Mayor; Four (4) members shall be residents of the City and appointed by a majority vote of Council; One member shall be a member of Council's Economic Revitalization Committee who shall be appointed annually by the President of Council; One member shall be the Mayor or the Mayor's designee; One member shall be a Lycoming County Commissioner or a designee; and One member shall be the President of Lycoming College or his designee.
- (b) The initial term for the members appointed by the Mayor and by a majority of Council shall be as follows: Two (2) of the mayoral appointments and two (2) of the Council appointments shall serve a three year term; and two (2) of the mayoral appointments and two (2) of the Council appointments shall serve a five year term. Thereafter appointments to the Commission shall be for five year terms.
- (c) Vacancies in the Commission occurring otherwise than by expiration of term shall be for the unexpired term and shall be filled in the same manner as the original appointments.

SECTION 2. ARTICLE 199.03 – PURPOSE IS HEREBY AMENDED TO READ AS FOLLOWS:

- (d) The Commission shall be advisory to the Mayor and City Council on the revitalization of the east end of the City in an area bounded by the alley north of Washington Boulevard and Lycoming College along the northern edge, Market Street on the west, Interstate 180 on the south, and Catherine Street at the City border on the east. The duties of the Commission will include but not be limited to examining the effects of zoning, planning, parking, and the seeking of grants and other sources of funding for this area of the City.
- (e) City boards commissions, authorities are authorized and directed to cooperate with and assist the Commission.
- (f) The Commission is authorized to create advisory sub-committees and appoint its members one of whom shall be a member of City Council.
