Attached for your review and approval is a resolution authorizing the execution of a contract to Laporte Painting, Inc., 951 Peiffers Lane, Harrisburg, Pa 17109. This contract is for painting of the under structure of the roof canopy including the steel frame work over the grandstand seating area at Historic Bowman Field in the amount of \$64,000.00.

Laporte Painting submitted the low bid at a public bid opening held on May 5, 2014. Bid documents were supplied by Reynolds Construction Management to five vendors with two other bids received. In addition, Reynolds Construction made numerous attempts to have local companies participate in the bid process with none received. Funding for this project will be allocated from the bond proceeds.

The canopy painting was part of the 2000 Bowman Field Renovation Project. The current condition has several areas of unfinished (bare wood) underlayment, which were replaced as part of the roof project along with scaling and weathered conditions throughout the remainder. Reynolds will provide on-site inspection to insure compliance of the bid specifications by the contractor during the project.
