INCLUDING THE GENERAL FUND, CAPITAL PROJECTS FUND, LIQUID FUELS
FUND, CITY HALL OPERATING FUND, UNEMPLOYMENT COMPENSATION
FUND, DEBT SERVICE FUND, ACT 13 FUND, AND POOL REPAIRS CAPITAL




