## Business Privilege Tax Refund

WHEREAS the City Council of the City of Williamsport approves the refund of 2021 Business Privilege Taxes to H.A. Berkheimer, Inc. ("Berkheimer") in the **amount of \$13,350.69** as submitted by the City Treasurer to the City Council.

WHEREAS, these taxes were remitted from Berkheimer to the City of Williamsport as part of Berkheimer's 7/23/2021 disbursement for taxpayer 2021-1. These taxes were incorrectly remitted to the City of Williamsport and should have remained with Berkheimer and applied to a business account in a jurisdiction outside of Williamsport.

Berkheimer had previously accepted payments in the amount of \$13,544.00 for taxpayer 2021-1 (for confidentiality). Berkheimer believed that these payments belonged to the City of Williamsport and remitted these tax payments to us as part of their regular distribution on 7/23/2021 – see attached. The total payment to the City from Berkheimer for these specific payments was \$13,350.69 because they retained 1.5% of the payment as their commission.

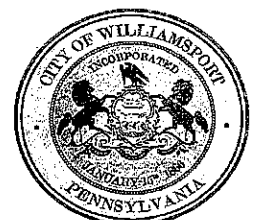
