AN ORDINANCE

6439

VACATING SPRING GARDEN STREET IN THE EIGHTH WARD

BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLIAMSPORT AND IT IS HEREBY ENACTED UNDER THE AUTHORITY OF THE SAME THAT:

SECTION I:

The entirety of Spring Garden Street, west of Franklin Street, between East Edwin Street and East Fourth Street in the eighth ward of the City of Williamsport, County of Lycoming, Pennsylvania as described as follows is hereby vacated.

Beginning at a point at the intersection of the northern right of way line of East Fourth Street and the western right of way line of Spring Garden Street, thence in a northerly direction along the western right of way line of Spring Garden Street (208) feet to the southern right of way line of East Edwin Street, thence in an easterly direction along the southern right of way line of East Edwin Street (20) feet to the eastern right of way line of Spring Garden Street, thence in a southerly direction along the eastern right of way line of Spring Garden Street (208) feet to the northern right of way line of East Fourth Street, thence in a westerly direction along the northern right of way line of East Fourth Street (20) feet to the western right of way line of Spring Garden Street the point and place of beginning.

SECTION II.

The proper City officials are hereby authorized and directed to reflect the above-mentioned change on the official map of the City of Williamsport

SECTION III.

All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

SECTION IV.

This ordinance shall become effective upon final enactment.
