## HONORING FIRE PLATOON B

WHEREAS, on Monday, February 25, 2019, Lycoming County dispatched Station 1, Williamsport Bureau of Fire to 627 Third Ave., for a report of smoke coming from a home. And recognizing the members of B-Platoon for actions carried out during this incident that reduced injury to the interior crew and saved their lives.

WHEREAS, THE MEMBERS OF B-PLATOON WHILE INITIALLY OPERATING AND CONDUCTING INTERIOR FIRE GROUND OPERATIONS AT WHAT WOULD BECOME A 3-ALARM FIRE. THE INTERIOR CREW CONSISTING OF: ACTING PLATOON CHIEF KEVIN HURNE, ENGINEER JEREMY VOGT AND FIREFIGHTERS JOEL SHIRN AND GREG DELANY RECOGNIZING RAPIDLY DETERIORATING CONDITIONS THROUGH TRAINING, SITUATIONAL AWARENESS AND EXPERIENCE, EVERTED SERIOUS INJURY OR TRAGEDY.


WHEREAS, The four member team suffered relative minor injuries during the event consisting of: first and second degree burns and an exposure element to what they have just been through, the team continued to fight fire along their brothers to stop the spread of fire to either of the exposure buildings located on either side of the original fire building until sufficient manpower arrived on scene to replace them.

WHEREAS, recognizing all members of the Bureau of Fire on the initial scene working at this incident, maintained a calm systematic approach to bringing the incident under control and to a calm resolve.

NOW THEREFORE, at our meeting assembled this 25th day of April, 2019, Williamsport City Council does hereby acknowledge and express on behalf of the citizens of the City of Williamsport our deep appreciation and gratitude for the contributions for the service and efforts displayed by the members of the Bureau of Fire and particularly the four firefighters who risk their lives every day to protect the citizens and property not just within the city boundaries but wherever we may be summonsed.

AND FURTHER, that the City Clerk is hereby directed to present copy of this resolution to the Williamsport Fire Fighters.
